

ORDINANCE NO. 2011-11

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PERRY, OKLAHOMA, AMENDING CHAPTER 5 OF THE PERRY MUNICIPAL CODE 2004 (3RD ANNUAL SUPPLEMENT), BY THE AMENDMENT TO SECTION 5-110, ENTITLED "INTERNATIONAL RESIDENTIAL CODE ADOPTED", PROVIDING FOR THE ADOPTION OF THE 2009 EDITION FOR THE CITY OF PERRY, OKLAHOMA; REPEALER; SAVINGS CLAUSE; CODIFICATION; SEVERABILITY; AND DECLARING AN EMERGENCY.

EMERGENCY ORDINANCE

Section I. That Chapter 5 of the Perry Municipal Code 2004 (3rd Bi-annual Supplement) is hereby amended by the amendment of Section 5-110 which shall read as follows:

Section 5-110 INTERNATIONAL RESIDENTIAL CODE ADOPTED.

That a certain document is on file in the Office of the City Clerk of the City of Perry, Oklahoma, being marked and designated as the International Residential Code, ~~2006~~ 2009 Edition, its appendices and annual amendments thereof, as published by the International Code Council, be and is hereby adopted as the Residential Code for the City of Perry, State of Oklahoma, for regulating and governing the construction, alteration, enlargement, replacement, repair, equipment, location, removal and demolition of detached one and two family dwellings and multiple single family dwellings (townhouses) not more than three stories in height with separate means of egress as herein provided; providing for the issuance of permits and collection of fees therefore; and each and all of the regulations, provisions, penalties, conditions and terms of said Building Code on file in the office of the City Clerk of the City of Perry, Oklahoma, are hereby referred to, adopted, and made a part hereof, as if fully set out in this ordinance, with the additions, insertions, deletions and changes:

Section II. REPEALER. All ordinances or parts thereof which are inconsistent with this ordinance are hereby repealed.

Section III. SAVINGS CLAUSE. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding now pending in any court, or any rights acquired or

liability incurred nor any cause or causes of action accrued or existing, under any act or ordinance repealed hereby. Nor shall any right or remedy of any character be lost, impaired or affected by this ordinance.

Section IV. CODIFICATION. This ordinance shall be codified as herein provided.

Section V. SEVERABILITY. If any one or more of the sections, sentences, clauses or parts of this ordinance, chapter or section shall for any reason be held invalid, the invalidity of such section, clause or part shall not affect or prejudice in any way the applicability and validity of any other provision of this ordinance. It is hereby declared to be the intention of the Mayor and City Council of the City of Perry, Oklahoma, that this section of the Perry Municipal Code would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

Section VI. EMERGENCY. WHEREAS, it being immediately necessary for the preservation of the peace, health, safety and public good of the City and the inhabitants thereof that the provisions of this Ordinance be put into full force and effect in order to immediately adopt the 2009 Edition of the International Residential Building Code; By reason whereof, this Ordinance shall take effect and be in full force and effect after its passage, as provided by law.
